Submission: Authors are encouraged to submit their manuscript electronically to research@ciir.in with the domain name (Arts/Science/Medical/Biotechnology/Engineering) in the subject line.

Publication Time: Authors will receive a reviewer's comment in 6-7 days of submission of final manuscript and the published paper would be available online in a week after the submission of copyright form (link for online submission of copyright https://forms.gle/53KMU1SktBLRt9bu9).

Copyright: The statement must accompany all manuscripts submitted for publication in whole or in part for publication. For the mutual benefit and protection of authors and publishers, authors must authorize publication and send in a copyright form before publishing a work. You may use the above link to submit the copyright form else please fill the form (available at https://cutt.ly/UQzaNUC) and email a scanned copy of the filled form to research@ciir.in or send through post to Council of Industrial Innovation and Research (CIIR), B-17, Sector-6, Noida, Uttar Pradesh, INDIA, 201301.

Publishing Fee: Free of Cost (Unpaid)

*Paper Format*: The manuscript should be emailed to the editor with attachments. The file must be written in MS-WORD or PDF format for IBM-compatible computers.

Length of Paper: IJMIR transactions doesn't have any limitation on number of pages.

Sequencing Order: article title, author name, author's institution, abstract (150-200 words), body, table and caption, list of symbols and abbreviation (if necessary), numbered References, biographical sketches, original drawings.

Title: The article title should be definitive and concise (including searchable keywords).

Abstract: You should open your article with a short resume (up to 200-300 words).

- (1) Abstract clearly indicate the purpose, scope and results of the work so that the reader can decide whether the entire text will be of special interest to them;
- (2) Provide keywords and expressions for indexing, summarizing and searching.

*Reference*: References should be presented at the end of the article and numbered in the order of the articles. References should be cited in the following examples in Times New Roman (10).

*Evidence*: Evidence is sent to the author and must be returned within 1 week of receipt. Correction should be limited to printing errors. All other corrections are due to the authors. Late repairs may not be included, so authors are advised to carefully check the evidence prior to check-in. Corrected answers must be returned to the publisher.

Frequency of publication: Four times a year (Quarterly—Jan, April, July, October).
